The Licence is granted subject to the following conditions:

- The Licence shall be non-transferable.
- The number of workmen employed as contract labour in the establishment shall not, in any day exceed 80 Workers at M/s Rajiv Gandhi Cancer Society and Research Centre, Sector-5, Delhi-
- 3. Except as provided in the rules the fees paid for the grant / renewal of the Licence shall be nonrefundable
- The rates of wages payable to the workmen by the contractor shall not be less than the rates prescribed for the Schedule of employment under Minimum Wages Act, 1948 where applicable and where the rates have been fixed by agreement/settlement or award, not less than the rates fixed.
- In case, where the workmen employed by the contractor perform the same or similar kind of work as the workmen directly employed by the Principal Employer of the establishment, the wages rates, holidays, hours of work and other conditions of service of the workmen of the contractor shall be the same as applicable to the workmen directly employed by the Principal Employer of the establishment on the same or similar kind of work; provided that in the case of any disagreement with regard to the type of work to same shall be decided by the Labour Commissioner, Govt. of N.C.T. of Delhi whose decision shall be final.
- In other case the wage rates, holidays, hours work and conditions of service of the workmen of the contractor shall be such as my by specified in this behalf by the Labour Commissioner, Govt, of N.C.T. of Delhi.
- In every establishment where 20 or more women workmen are ordinarily employed as contract labour there shall be provided and maintained a suitable room or rooms of reasonable dimensions, for the use of their children under the age of six years. For this purpose the contractor shall supply adequate number of toys and games in the play rooms and sufficient number of cots and bedding in the sleeping room. The standard of construction and maintenance of the crèches may be such as may be specified in this behalf by the Labour Commissioner, Govt. of N.C.T. of Delhi.
- The Licensee shall notify any change in the number of workmen or the conditions of work to the Licensing Officer immediately.
- The Payment of wages to all the workers (other than workers engaged in construction work/ daily paid) should be made every month through A/c Payee Cheques/ ECS only. The payment of wages should be made in the presence of representative of Principal Employer, and duly verify by him/ her.
- 10. That the required information and documents should be uploaded on the website which should not be password protected and shall be updated every month. The information and documents should not be removed from the website without prior permission of Licensing Officer.

11. That non-compliance arrelations of any of the condition may lead to the revocation of Licence.
