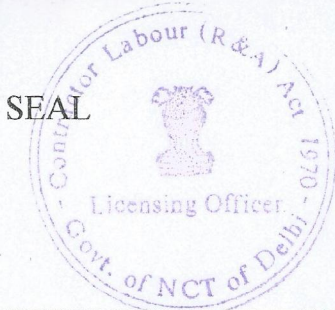

3. The Licence shall remain in force till 17.04.2014 to 19.03.2015 (for 80 workers).





